SyncTables Trial Version is not free software. The end of the evaluation period is marked on your copy of SyncTables. If you want to use this software after the expiration of this evaluation period, you must purchase a license for SyncTables. Any use of SyncTables Trial Version after the expiration date of the evaluation period without purchasing such a license is outside the scope of this license and a violation of international copyright laws.
